Please be advised that the healthcare plans in which our practice is a participating provider and the facilities with which our practice is affiliated are listed on our company website at www.americansurgicalarts.com. This information is also available to you upon request at our offices.

If your health plan is not listed on our website or communicated to you at the time of your appointment as a benefit plan that we participate in, please note, Dr. Sean Bidic and Dr. Vinay Gundlapalli do not participate in the network of your healthcare plan. As an out-of-network physician, Dr. Sean Bidic and Dr. Vinay Gundlapalli have not agreed to any set rate that your healthcare plan may pay, they may charge more. The estimated amount that will be billed to you is available upon request. However, if, unforeseen medical circumstances arise when services are provided, the amount that will be billed for services rendered may be higher.

Depending on your specific plan, you may have a financial responsibility for services related to your out-of-network deductible, co-pay and/or co-insurance. Additionally, you may be responsible for the portion of our charges that are not covered by your insurance and we recommend that you contact your insurance carrier for further information regarding the costs under your specific plan.

As a courtesy to our patients, we will bill your insurance company directly for reimbursement for our services. Occasionally, the insurance company will either mail the check or deposit our reimbursement for surgical fees directly to you. In these circumstances, we kindly request that you mail us a copy of the explanation of benefits (EOB) with the check from your insurance company endorsed by you, or in the case monies are being directly deposited, a check from you in the exact amount stated in the EOB made payable to American Surgical Arts. Failure to comply will force your account to become past due. This may result in the amount owed being turned over to a collection agency and may adversely affect your credit.
